You can include a gift to Reading Partners in your will or trust. Here are some sample provisions that your advisor can use to memorialize your charitable intentions for Reading Partners.

We encourage you to consult your attorney, accountant, or financial advisor to help determine what type of gift is best for you.

## **Specific Bequest**

With a specific bequest you can stipulate a percentage of your estate, or a dollar amount,	or specific
assets be given to Reading Partners. Examples may include:

## **Residuary Bequest**

With a residuary bequest, you can state that all, or a portion, of the estate be given to Reading Partners after specific gifts are distributed to other beneficiaries. Examples of this language may include:

- "I give all of the rest, residue and remainder of my estate to Reading Partners, a national nonprofit corporation based in Oakland, California, for its general purposes"
   OR to designate a specific region: "I give all of the rest, residue and remainder of my estate to
